2:30 PM The Changing Landscape of Long Term Care and its Implications for the Insurance and Reinsurance Industries

While many LTC insurers in the last century were optimistic that long-term care insurance would be a profitable and growing line of business, actual experience has not lived up to expectations. Insureds have lived longer, and often for long periods of time in expensive nursing homes, skilled nursing facilities, or other long-term care facilities, exposing insurers and reinsurers to significant losses on their blocks of LTC business. In this presentation, we'll discuss (1) litigation around LTC insurance and reinsurance; (2) rate increases on legacy LTC policies and the states' responses to such increases; (3) continuing regulatory developments regarding LTC insurance; (4) financial issues relating to LTC carriers; and (5) the purchase and sale of legacy LTC blocks by new and existing market players.
