Rob has briefed and argued numerous Clean Air Act cases in the U.S. D.C. and Sixth Circuits and Ohio Supreme Court and appellate courts, and has defended dozens of Clean Air Act enforcement actions and citizen suits in federal and state courts. He has been a principal counsel for electric utility defendants in EPA's power plant New Source Review enforcement initiative.

Rob is general counsel to the Ohio Chemistry Technology Council, a member of the Council Group and past chair of the American Bar Association Infrastructure and Regulated Industries Section (formerly the Section of Public Utility, Communications and Transportation Law), a Fellow of the American College of Environmental Lawyers, and a Fellow of the American Bar Foundation. He is coeditor of the *Government Institutes' Ohio Environmental Law Handbook*.
