A past trustee of the Southwestern Ohio Regional Transportation Authority and a member of many high-profile non-profit boards, Steve serves on the Hamilton County Regional Planning Commission and the USO Ohio board. He is a leader in the efforts to preserve the King Records building and tell the story of Cincinnati's rich music heritage to the rest of the country.
