There, he played a pivotal role in developing policies for, and the administration of, visas for highly skilled workers, people with extraordinary abilities, and foreign investors. John also worked on many complex global immigration matters including the response to national security risks associated with the EB-5 immigrant investor program and helping administer the Deferred Action for Childhood Arrivals program. He also worked to ensure unaccompanied minors seeking asylum in the U.S. received due process.

Prior to joining the Obama Administration, John served as senior counsel to Senator Patrick Leahy (D-VT), then-Chairman of the U.S. Senate Judiciary Committee. John conducted oversight investigations and advised the committee on civil and criminal justice, immigration and homeland security, foreign corruption, sovereign immunity and judicial
