Sean has represented clients in federal and state competition and consumer protection actions, with experience before state and federal courts, the Federal Trade Commission, and the European Commission's Directorate-General for Competition. He provides counsel on compliance with antitrust and related consumer protection statutes, ensuring his clients navigate these complex areas effectively.
